Bishop Demetri Khoury was prosecuted by your office for fourth degree criminal sexual misconduct and being drunk and disorderly. In 2004 he pleaded guilty to attempted fourth degree criminal sexual misconduct, a reduced charge, and was sentenced to 28 days in jail. Khoury was also required to register as a sex offender.

While Khoury was registered as a sex offender the last time I checked, in 2012, he no longer appears on any registry.

I am the Orthodox Christian Director for SNAP, the Survivors Network of those Abused by Priests. I'm wondering if you can tell me if his requirement to register had an end date? Khoury is now residing in Southern California, and has been returned to ministry by his church.
